### Principal's Report:

December 1st Principal Report

I have been in the Acting Principal role for Gympie Special School since Thursday the 13th of November. In this time, I have had the privilege of attending and addressing the Year 12 Graduation Ceremony, Year 12 Formal Dinner and the Year 6 Graduation Ceremony. These ceremonies are a special event for our community as they recognise the growth, development and success of our learners.

We have also had the recall of coloured sand from our classrooms as a directive from our Director General. All sand has been packaged safely and removed offsite. We also had a deep clean to several of our school areas where the sand was stored, and a classroom that required deep cleaning as the sand had been recently used. All areas have been cleaned, tested and cleared for use by the QBuild and the specialist cleaners.

We have organised our classroom structures and locations for 2026, these are in draft now as changes always happen. These will be released next week to families. We have increased in size

for 2026, taking in new enrolments of 15 Prep students, 2 Primary and 1 Secondary student. We will be beginning the year at maximum capacity of 102 students and 18 classes:

- · 7 Early Years classes
- · 4 Primary classes
- · 6 Secondary classes
- · 1 Senior class

I am working with facilities to make improvements to classroom spaces to make it safer for our Early Years students who are needing to move out of the fenced in Early Years spaces. Planning has also begun, and architectures employed to begin the process of the proposed 2 Level Building of classrooms to accommodate our growing school community.
